SUMMER TAXES are payable to Grosse Ile Township July 1, 2017 thru September 14, 2017 without penalty. *Beginning Sept. 15th a 1% penalty per calendar month will be added.*

WINTER TAXES are payable to Grosse Ile Township Dec 1, 2017 thru Feb. 14, 2018 without penalty. *Beginning Feb. 15th thru March 1st a 3% penalty will be added.*

If you have an escrow account through your mortgage company, a copy of this bill has been forwarded to them only if the company requested a duplicate bill for payment. If you are unsure please call your mortgage company or the Grosse Ile Township Treasurer's office.
