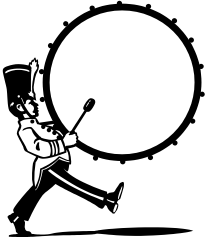

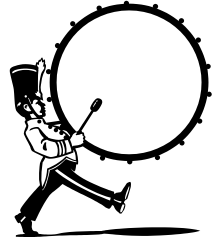

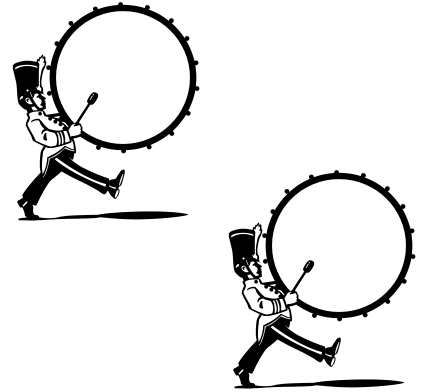

PARADE FACTS POLICY AND REGULATIONS

1. All units must be in place one-half hour before parade start time.
2. All marching units will be required to maintain a forward motion at all times (excluding temporary stoppage of parade).
3. Units with sirens-please do not use them (exception; Fire Dept. / Lead Unit). This is a precautionary and courtesy measure of equestrian units, musical units and young children.
4. All mechanical equipment must be in sound condition, equipped with a tow bar or chain, mounted in the front of the vehicle; carry an emergency portable fire extinguisher; be at the assigned formation position and ready for inspection by the Festival Commission.
5. Entry must be covered by adequate insurance and be prepared to provide proof on request.
6. To insure spectator safety, the Festival Commission discourages parade participants from throwing or distributing objects to spectators.
7. Political Candidates are allowed to participate and carry signs, but no campaigning or literature handouts.
8. Placement in the parade is at the sole discretion of the Festival Commission.
